Application Information

- A separate application is required for each media category.
- Artists may submit only original artwork.
- Please submit 3 images of current work and 1 image of booth with application. Applications without images will not be considered.
- Images may be submitted by email or via an image sharing website (ex. Dropbox/WeTransfer). No hard copies please.

Exhibitor Essentials

- The show site is outdoors at Historic Honey Horn rain or shine. There is no scheduled rain date so please plan accordingly.
- Assigned booth space will be 10'x10' with space between and behind each booth. Booth spaces are arranged near our centuries-old live oak trees and in a grassy area.
- All artists must provide equipment needed for their booth space. Each booth must be secured with 50lb weights on each leg. Artists are responsible for any damage caused to the property by their equipment or displays.
- Only artists displaying their original artwork may operate the booth. No agents, resellers, production works, or buy/sell is permitted. The Coastal Discovery Museum reserves the right to remove unsuitable works or vendors at the time of the show and booth fees will not be refunded.
- If two artists collaborate on a body of work, each artist must be listed on the application and both must be present at the show.
- A convenient exhibitor parking area is provided near booths. Artists may leave trailers overnight on site in a designated area. Overnight security is onsite Friday and Saturday evenings and the property is gated and monitored by security cameras.
- Exhibitors are required to collect 6% SC sales tax and report to the SC Department of Revenue. Your booth fee includes a Town of Hilton Head business license for the duration of the show.
- Participating artists must have a SC Department of Revenue retail license or arts and craft license if they sell at more than four events per year.

January 11, 2026 - Application, images, \$35 jury fee per category due. Late application fee is \$50.

January 30, 2026 - Notifications emailed to artists for acceptance, wait list, or rejection.

February 27, 2026 - Booth fees (\$235) due.

March 13, 2026 - Last day for artists cancellation with 100% refund minus \$25 processing fee. No refunds after this date.
